### Finance and Accounting Department

The team processes various financial information generated by the company in accordance with Spanish Accounting law, confirms taxes in accordance with tax laws and tax policies, and manages the flow of various funds and expenses. The department prepares the company's short-, medium- and longterm planning and budget and business plans.

Partnering with operation departments, the Finance and accounting review financial performance, investigate profit improvement opportunities and recommend actions that promote improved financial results. Financial accounting provides financial information for decision-making by users of accounting information. We prepare and disclose individual and consolidated financial statements and notes on a guarterly basis and perform external audits.

Management Accounting provides useful information for internal management to make rational decisions, including budgeting, service, departmental sales and profit and loss reporting, and cash forecasting. The regular tasks include budgeting (individual and consolidated), estimating and finalizing monthly profit and loss, and reporting profile and loss details.

Regarding tax management, we cooperate with external firms, reviewing and managing revised tax laws. The regular tasks include checking value-added tax, corporate tax and various obligated reporting that must be done regularly.

The candidate will be responsible for overseeing all accounting activities and financial analysis activities and working with staff responsible for operating group level decision support activities. This includes, but is not limited to, the publication and communication of financial results, the quarterly process for segment budgeting and forecasting, and the coordination and communication of requests for capital.
